Ordinance 03-15-2024-01- Budget Amendment #2

Ordinance 03-15-2024-02 – Establishing Licensure Requirements for Solar Energy Systems

Judge Young conducted first reading of the ordinance. This is to follow the statute to codify the requirements. Local board will be created to administer. Motion to approve made by Boone, second by Stallins.

Ordinance 03-15-2024-03 Policies and Procedures – Animal Shelter: Second Reading Motion made by Stallins, second by Boone.

The Road Committee report concerning Wildwood Point was presented to the court, pursuant to Ordinance 03-23-99. Serita Jaggers and Kelsey Crisp (residents) again questioned the Road Committee's recommendation to not add it to the County road system. Committee Chairman addressed their concerns. Jaggers and Crisp asserted that no other road had ever been rejected by the court. Simms stated that this court could not be held responsible for actions taken by previous courts, but that this court intended to uphold the ordinance. Judge Young thanked the citizens for voicing their concerns. No further action was taken.

Motion to authorize Treasurers Transfers was made by Bennett, second by Stallins.

Kevin Lane presented an award to Miranda Johntry, employee at the County Animal Shelter for going above and beyond duty by rescuing a dog while not on duty at work.

County Clerk Hale informed the public of the use of the Butler Gym as a new location for a Vote Center in the May primary election. She added that all polling places are considered Vote Centers now with the addition of the Print on Demand printers awarded to the county through a state grant. Any voter can vote at Butler Gym; Crossroads Christian Church; Donaldson Baptist Church; and the Fredonia Lions Club. This move was necessary due to the former Vote Center, Southside Lifecenter, being unavailable for early voting this year.

Early Excused absentee voting will take place 5/8, 5/9, 5/10, 5/13,5/14, and 5/15 in the clerks office from 8:00am to 4:00pm in the clerk's office. Early no-excuse absentee voting will take place 5/16 and 5/17 from 8:00 to 4:00; and 10:00 to 6:00pm on 5/18. Election day is 5/21; polls open at 6:00am and close at 6:00pm.

Sheriff Weedman addressed the problem of dumping in the county, and urged citizens to stop, for they will be prosecuted. Judge Young stated that he is working on a solution for the loss of the county's processing power at the Recycling Center.

Judge Young announced the court's next regular meeting is scheduled for Tuesday, March 26, 2024. Paperwork is to be turned in by Friday, March 22, 2024, by noon.

Motion made by Boone and second by Stallins to be adjourned. Court adjourned.
